8. To do everything necessary, suitable or proper at anytime or place for the establishment and accomplishment of any of the purposes and objectives herein set forth, and to contract accordingly in behalf of the Foundation;
9. To exercise any power or powers necessary for the accomplishment of its purposes, and to engage in any activity which a Foundation may ordinarily or customarily engage in;




