WHEREAS, due to the continuous heavy rains flooding on the lakeside shorelines, creek sides, and other low lying areas have much effect on the communities settling along the lakeside from Barangay Sucat to Barangay Tunasan;

WHEREAS, the flooding of the said areas causes difficulties to students, factory workers and all residents residing along the said areas;

WHEREAS, Section 5, (a) of Rules and Regulations implementing R. A. 8185 states that, "allocation - the 5% calamity fund shall be set aside as annual lump sum appropriation for every calendar year in the annual budget of the local government unit to be allocated to areas affected by the disaster or calamity. Local Government Units may also allocated for the use of a portion of the 5% calamity fund to other affected areas on condition that the said areas are declared as in a state of calamity by the Sangguniang Panlungsod;"

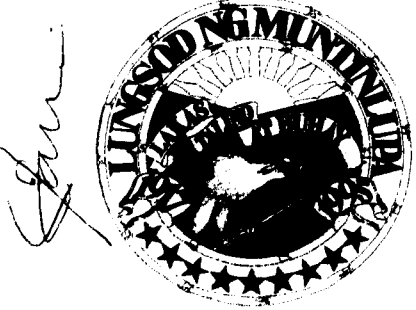


- a. for the immediate rehabilitations of roads, pathways, creek side and waterways and rip raps;

- c. For the purchase of coco lumber and other construction materials for temporary bridge to connect houses under waters to areas not affected by flood waters;


