WHEREAS, thousands of families within the NBP Reservation which include employees of the Bureau of Corrections and their dependents, public school teachers and their dependents and other long time residents will be affected by the said planned transfer;

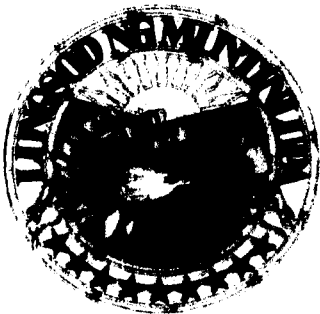
WHEREAS, not only will they be displaced in their places of residences but also affected in terms of their jobs, security and well-being of their family members;
