WHEREAS, there are about *two thousand seven hundred seventy seven (2,777)* students presently enrolled at *Itaas Elementary School* located at Barangay Poblacion, Muntinlupa City, but only *forty (40) classrooms* are available to accommodate the said number of students;

WHEREAS, there is an urgent need to construct a three (3) storey school building to cater the needs of said students for a better and quality education;
