WHEREAS, in connection with the collection of the foregoing fees and rentals by the Interim Market Committee, the City Treasurer's Office of Muntinlupa City is hereby authorized to issue and prepare the corresponding receipt for the payment to be made by every market vendor or for every market fee, which receipt shall be dated on the same day of issue, with the corresponding stall number written thereon.

WHEREAS, the rates above-prescribed shall be subject to regular or periodic review and adjustment based on the recommendation of the Interim Market Committee should there be any adjustments, this resolution shall be amended accordingly.

NOW, THEREFORE, be it **RESOLVED** as it is hereby resolved to grant HON. **ATTY. JAIME R. FRESNEDI**, City Mayor of Muntinlupa, the power to impose and collect market fees and rentals pursuant to the above prescribed rates and to grant the City Treasurer the power to issue the corresponding receipts for the payments made.






