WHEREAS, the City Government is *renting two office spaces with an area of forty three (43) square meters and situated in Bruger Subdivision, Putatan, Muntinlupa as a warehouse for the Accounting Office;*

WHEREAS, the *monthly rental for each office space is Five Thousand Five Hundred Pesos (P5,500.00) or a total of Eleven Thousand Pesos (P11,000.00), with a ten percent (10%) increase yearly effective from May 1, 2002 to April 30, 2004;*

WHEREAS, there is an *available budget for the rental of the said building from May 1, 2002 up to December 31, 2002 in the current Executive Budget and the rental fee for the subsequent years shall be included in the yearly Executive Budget;*

NOW, THEREFORE, BE IT RESOLVE, AS IT IS HEREBY RESOLVED by the Members of the Sangguniang Panlungsod duly assembled to authorize *Hon. Mayor Jaime R. Fresnedi* to sign for and in behalf of the City Government *the Contract of Lease, covering the period from May 1, 2002 to April 30, 2004, with Bruno O. Gundran, Jr. for the two office spaces, with a monthly rental of Eleven Thousand Pesos (P11,000.00) and with a ten percent (10%) yearly increase, located in Bruger Subdivision, Putatan, Muntinlupa City used as a warehouse of the Accounting Office.*
