WHEREAS, City Ordinance No. 02-045 created Task Force C.A.R.E.S. to establish an alternative route within the City of Muntinlupa from Victoria Homes in Brgy. Tunasan to Filinvest Land in Brgy. Alabang and vice versa;

WHEREAS, said alternative routes shall ease the volume of traffic at the National Road, Old Provincial (Aplaya) Road and South Superhighway particularly the Alabang Viaduct;

WHEREAS, without this Resolution, owners possessors, and occupants of the routes involved may not negotiate and may not enter into contract with Mayor Jaime R. Fresnedi on behalf of the City of Muntinlupa;

WHEREAS, the project will contribute to the development and progress of Muntinlupa City, specifically the barangays and subdivisions affected therein;

WHEREAS, there is a need to authorize the City Mayor of Muntinlupa to negotiate and enter into such contracts may be necessary for the implementation of the C.A.R.E.S. project under City Ordinance No. 020-145.

WHEREAS, pursuant to Sec. 455 (b)(1)(iv) of the Local Government Code and its Implementing Rules and Regulations, and, the charter of Muntinlupa City, the City Mayor is authorized to enter into contracts for and in behalf of the City Government subject to approval by the Sangguniang Panlungsod.






