A RESOLUTION AMENDING RESOLUTION NO. 02-120 OTHERWISE KNOWN AS "A RESOLUTION ADOPTING THE MEMORANDUM OF UNDERSTANDING ON THE SIMPLIFICATION OF THE CIVIL REGISTRY SERVICES", AND INSERTING ADDITIONAL WHEREAS CLAUSE AFTER THE SEVENTH (7TH) WHEREAS CLAUSE.

WHEREAS, the LCRO with two (2) more divisions added to its organization (NSO-OCRG Extension Office/Census Serbilis Center and Legal and Administrative Division, increased quasi-judicial function under Republic Act No. 9048 and supervisory function for NSO-OCRG Extension Office/Census Serbilis Center needs 40% share or Twenty Pesos (P20.00) per copy from collections in the issuance of certifications by the offices which supervises to continue its efficient and effective delivery of services to the constituents of Muntinlupa City and neighboring cities/municipalities for its annual departmental budget remained essentially the same since 1995;

WHEREAS, paragraph 7 of Resolution No.02-120 provide that, "Whereas, the Local Civil Registry Office of the City of Muntinlupa, shall impose a service fee in the issuance of a Civil Registry Document in SECPA in the amount of Fifty Pesos (Php50.00), still lowest in comparison with the amount being collected by the neighboring cities and Municipalities.";

WHEREAS, there is a need to insert additional paragraph providing for the division of fees stated above, which shall be read as follows:

"WHEREAS, out of the fifty pesos (Php 50.00) collection of the City Government of Muntinlupa, thirty pesos (Php 30.00) shall go to the Local Treasury (General Fund), and the twenty pesos (Php 20.00) shall go to the TRUST FUND, to be set up by the Local Civil Registry Office Of Muntinlupa City for the improvement of the delivery of civil registration services including construction of amenities, purchase of office supplies specifically security paper and photocopying supplies, furniture and equipment, transportation expense, allowances and salaries of personnel if such fund/income is still adequate";




