WHEREAS, Article II Section 15 of the 1987 Philippine Constitution provide that "The State shall protect and promote the right to health of the people instill health consciousness among them";

WHEREAS, the Department of Health (DOH), pursuant to the Local Government Code of 1991 transferred the responsibility for the health services delivery and program implementation to the local government units (herein referred to as LGU's);

WHEREAS, the DOH retains, among others, the functions of developing special health programs and projects and extending support services and other forms of assistance to the LGU's such as technical, administrative, logistics and financial report;

WHEREAS, the DOH wants to support the LGU in expanding the coverage of family planning, maternal and child health, and nutrition services;

WHEREAS, the Matching Grant Program (MGP) is a program under the DOH with funding assistance from the USAID which aims to provide technical and financial assistance to cities and municipalities to expand health services delivery especially among women and children;

WHEREAS, the following are the criteria set forth for the selection of LGU's as recipients of the MGP:

1. LGU with at least a population of 80,000

2. LGU within the coverage site for health sector reform

3. Economically disadvantaged LGU's


