A RESOLUTION AUTHORIZING THE CITY MAYOR ATTY. JAIME R. FRESNEDI TO SIGN FOR AND IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA THE DEED OF ABSOLUTE SALE AND MEMORANDUM OF AGREEMENT (MOA) TO PURCHASE A PARCEL OF LAND, WITH AN AREA OF 4,299 SQUARE METERS, MORE OR LESS, LOCATED AT PUTATAN, MUNTINLUPA CITY, AND REGISTERED IN THE NAME OF REFEDOR **DEVELOPMENT PROPERTY MANAGEMENT** & **SOUTHGOLD** CORPORATION, COVERED BY TRANSFER CERTIFICATE OF TITLE (TCT) NO. 9247, TO SERVE AS SITE FOR THE MUNTINLUPA CITY VOCATIONAL AND TECHNICAL SCHOOL AND OTHER GOVERNMENT PROJECTS IN THE AMOUNT OF FOUR MILLION SEVEN HUNDRED TWENTY EIGHT THOUSAND NINE HUNDRED PESOS (P4, 728,900.00).

WHEREAS, the seller offered a parcel of land, containing an area of 4,299 square meters, more or less, located in Putatan, Muntinlupa City, registered in the name of Refedor Southgold Property Management & Development Corporation, covered by Transfer Certificate of Title (TCT) No. 9247 for One Thousand Five Hundred Pesos (P1,500.00) per square meter;

WHEREAS, the City Government requested the seller to reduce the price to One Thousand One Hundred Pesos (P1,100.00) per square meter, or a total price of Four Million Seven Hundred Twenty Eight Thousand Nine Hundred (P4,728,900.00) and the said seller agreed. The said price is reasonable because the zonal valuation in the area of the Bureau of Internal Revenue (BIR) per appraisal report is One Thousand Three Hundred Pesos (P1, 300.00) per square meter;

WHEREAS, the seller requested the City Government to give 50% of the total price or Two Million Three Hundred Sixty Four Thousand Four Hundred Fifty Pesos (P2, 364,450.00) so that the same can be used in the payment of all taxes and other fees in the transfer of the title to the City Government;

WHEREAS, the seller shall pay the Capital Gain Tax, Transfer Fees, Registration Fees and other fees required to transfer the title to the city government;

WHEREAS, the fund shall come from the School Board Fund;
