WHEREAS, on March 19, 2003, the Department of Justice Secretary Simeon Datumanong informed the Department of Finance in a letter that the DOJ has initiated a study on the privatization of the New Bilibid Prisons;

WHEREAS, pursuant to the said study, Her Excellency, President Gloria Macapagal-Arroyo has directed the secretaries of the Department of Environment and Natural Resources and the Department of Defense and the HUDCC chairman to assist the DOJ in studying the proposed transfer of the prison establishment inside the National Bilibid Prison Reservation in Muntinlupa to Tanay, Rizal;

WHEREAS, the said directive is based on Executive Order No. 33, dated October 26, 1998 which created a Presidential Committee to study and take charge in the modernization and development of various penal institutions in the country, particularly the NBP property with an area of about 400 hectares, with the possibility of disposing such property and transferring said penal institution;

WHEREAS, the Committee is composed of the Executive Secretary as chairman; Secretary of Justice, vice chairman; Secretary of Budget and Management, member; Secretary of Public Works, member and Public Estates Authority, member;

- 1. Section 2 (c): "It is likewise the policy of the State to require all national agencies and offices to conduct periodic consultations with appropriate local government units, non-governmental and people organizations and other concerned sectors of the community before any project or program is implemented in their respective jurisdiction."
- 2. Section 26: "It shall be the duty of every national agency or government owned or controlled corporation authorizing or involved in the planning and implementation of any project or program that may cause pollution, climatic change, depletion of non-renewable resources, loss of cropland, range land, or forest cover, and extinction of animal or plant species, to consult with the local government units, non-governmental organizations, and other sectors concerned and explain the goals and objectives of the projects or program, its impact upon the people and the community in terms of environmental or ecological balance, and the measures that will be undertaken to prevent or minimized the adverse effect thereof."
- 3. Section 27: "No project or program shall be implemented by government authorities unless the consultations mentioned in Section 2 (c) and 26 hereof are complied with, and prior approval of sanggunian concerned is obtained: Provided, that the occupants in areas where such projects are to be implemented shall not be evicted unless appropriate relocation sites have been provided, in accordance with the provisions of the Constitution."

WHEREAS, its inclusion will ensure that the interests of the City Government and other sectors directly affected will be protected;

WHEREAS, its inclusion will likewise ensure that the City Government will be involved in the planning stage as well as in the implementation of any development project in the NBP Reservation which is crucial to its over all development as a premier city in the 21st Century;

NOW THEREFORE, BE IT RESOLVE, AS IT IS HEREBY RESOLVED, by the Sangguniang Panlungsod of Muntinlupa to request Her Excellency, President Gloria Macapagal-Arroyo to include the City Government of Muntinlupa in the Presidential Committee created under Executive Order No. 33 dated October 26, 1998.
