WHEREAS, Ordinance No. 02-067 entitled, " An Ordinance converting the Muntinlupa Drug Abuse Prevention and Control Council (MDAPACC) to Drug Abuse Prevention and Control Office (DAPCO), defining its powers and functions and providing funds thereof", was passed by the Sangguniang Panlungsod on October 17,2002;

WHEREAS, a letter endorsement submitted to the Office of the Vice Mayor, dated March 14, 2003, from City Administrator, Atty. Henry A. Reyes, requesting the honorable members of the Sangguniang Panlungsod to pass a resolution authorizing the Honorable City Mayor, Atty. Jaime R. Fresnede, to open a Special Account for funds derived from drug-testing and other sources for drug-related activities;

WHEREAS, the Special Account shall be used for the **programs and activities of the Drug Abuse Prevention and Control Office (DAPCO);**

WHEREAS, the funds to be collected shall be deposited in the name and for the account of the City Government of Muntinlupa as a "Special Account", from which shall be drawn the expenses relative to the operation and implementation of the programs and activities related to drug abuse prevention;

WHEREAS, all the disbursements shall follow the usual Accounting rules and procedures of the City Government of Muntinlupa;
