A RESOLUTION AMENDING RESOLUTION NO. 02-151 OTHERWISE KNOWN AS, "A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ATTY. JAIME R. FRESNEDI, TO OPEN AND MAINTAIN A SEPARATE ACCOUNT IN THE NAME OF THE CITY OF MUNTINLUPA, IN CONNECTION WITH THE FUNDS OF THE INTERIM MARKET COMMITTEE FOR THE NEW MUNTINLUPA PUBLIC MARKET" BY EXPANDING THIS SCOPE OF THE "TRUST ACCOUNT" COVERAGE TO INCLUDE EMPLOYEE BENEFIT AND STAFF DEVELOPMENT.

WHEREAS, Resolution No. 02-149 mandates the creation of an Interim Market Committee whose primordial function and duty is to control, manage and supervise the New Muntinlupa Public Market;

WHEREAS, Resolution No. 02-150 mandates the Interim Market Committee to collect and impose reasonable market fees and rentals for the market vendors;

WHEREAS, Resolution No. 02-151, a resolution authorizing the *City Mayor Hon. Atty. Jaime R. Fresnedi*, to open and maintain a separate account in the name of the City Government of Muntinlupa, in connection with the funds of the **Interim Market Committee (IMC)** for the New Muntinlupa Public Market, was passed on 29th of August 2002;

WHEREAS, the 3rd whereas clause of the approved Resolution No. 02-151, states among others x x x ,

"Whereas, the fees and rentals to be collected from the market vendors shall be deposited in the name and for the account of the City of Muntinlupa as a 'Trust Account', part of which shall be drawn the expenses relative to the operation, management, development and improvement of the public market";

WHEREAS, the 3rd whereas clause of the Resolution No. 02-151 shall be amended to read as follows:

"Whereas, the fees and rentals to be collected from the market vendors shall be deposited in the name and for the account of the City Government of Muntinlupa as a "Trust Account", part of which shall be drawn the expenses relative to the operation, management, development and improvement of the public market, including employee benefits and staff development.

WHEREAS, the employees of the New Muntinlupa Public Market, being on a job order status has no employees benefit whatsoever;

WHEREAS, these hardworking and dedicated employees equally deserve employee benefits and staff development enjoyed by their co-employees of the city government;

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, by the Sangguniang Panlungsod duly assembled to amend Resolution No. 02-151 otherwise known as "A Resolution Authorizing The City Mayor Hon. Atty. Jaime R. Fresnedi, To Open And Maintain A Separate Account In The Name Of The City Of Muntinlupa, In Connection With The Funds Of The Interim Market Committee For The New Muntinlupa Public Market" by expanding this scope of the "Trust Account" coverage to include employee benefit and staff development.


