WHEREAS, Section 454 (d) of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991 states that: *"unless otherwise provided herein, Heads of Departments and Offices shall be appointed by the City Mayor with the concurrence of the majority of all Sangguniang Panlungsod members, subject to civil service law, rules and regulations. The Sangguniang Panlungsod shall act on appointment within fifteen (15) days from the date of its submission, otherwise the same shall be deemed confirmed."*

WHEREAS, *Mr. Chito C. Valerio* of the Urban Poor Affairs Office is appointed as Department Head III;

WHEREAS, *Mr. Chito C. Valerio* meets the required qualifications under the Local Government Code and Qualifications Standard as set by the Civil Service Commission;

RESOLVE, THEREFORE, AS IT IS HEREBY RESOLVED, by the Sangguniang Panlungsod to confirm the appointment of *Mr. Chito C. Valerio* as *Department Head III* of the *Urban Poor Affairs Office*.
