WHEREAS, the City Government of Muntinlupa engaged the services of Engr. Rodrigo Marcelo, Geodetic Engineer, for the relocation, consolidation and subdivision survey of fifty-one (51) parcels of land that it owns into two titles, containing a total area of twenty-four thousand two hundred ninety four square meters (24,294 sq. meters);

WHEREAS, the consolidation resulted into two titles, namely Lot 1, Pcs-00-010046, containing an area of five thousand square meters (5,000 sq. meters) where the Muntinlupa Science High School is located and Lot 2, Pcs-00-010046, containing an area of nineteen thousand two hundred ninety four square meters (19,294 sq. meters) which lot is adjacent to the said Muntinlupa Science High School;

WHEREAS, the City Zoning Administrator and Planning Head' is recommending approval of the relocation, consolidation and subdivision survey of said land;

WHEREAS, there was a need to engage the services of a geodetic engineer, in the person of Engineer Rodrigo Marcelo, to conduct the relocation, consolidation and subdivision survey of the said land for which he must be paid professional services amounting to Seventy Six Thousand Pesos (P76,000.00).

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, by the Sangguniang Panlungsod, that a resolution be passed granting the approval of the relocation, consolidation and subdivision survey of fifty-one (51) parcels of land into two titles containing a total area of twenty-four thousand two hundred ninety four square meters (24,294 sq. meters).




