WHEREAS, the education of the youth is the highest priority in the eight-point program of the administration of Mayor Jaime R. Fresnedi;

WHEREAS, the Muntinlupa Scholarship Program under the management and supervision of the Muntinlupa Scholarship Foundation is one of the concrete programs in education of the administration which started in 1991 to give the youth of Muntinlupa the opportunity to attain college education;

WHEREAS, hundreds of scholars have benefited and continue to benefit from this laudable program, including the Ten Most Outstanding Students of Muntinlupa who are chosen every year;

WHEREAS, the source of funding of the program is the fifty percent share from the terminal fees collected from the Alabang Jeepney Terminal;

WHEREAS, as of June 2003, the funding has a negative balance of Six Million One Hundred Twenty Seven Thousand Five Hundred Sixty Six Pesos and 56/100 (P6,127,566.56) as the expected income from the contract entered into between the City Government and Joint Venture of Aysel Construction and Development Corporation to manage the jeepney terminal was not met as provided for in the said contract;

WHEREAS, there are at present 151 scholars for school year 2003-2004 depending on the Muntinlupa Scholarship Program;

WHEREAS, in view of the growing shortage of funds to finance the program, there is a need to find other sources of funding;

WHEREAS, in order to ensure the continuity of this noble program, the City Accountant suggested and the City Mayor and the Board of Trustees of the Muntinlupa Scholarship Foundation agreed to augment the funding of the program by applying thirty percent (30%) of the thirty percent (30%) share of the City Government in the proceeds of the parking fee taken from Metropolis Terminal;

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the Sangguniang Panlungsod of Muntinlupa, to increase the funding of the Muntinlupa Scholarship Program to be taken from the thirty percent (30%) share of the City Government in the proceeds of the parking fees from the Metropolis Terminal *be passed*.
