A RESOLUTION RATIFYING THE MEMORANDUM OF AGREEMENT BETWEEN THE CITY GOVERNMENT OF MUNTINLUPA AND THE NATIONAL IRRIGATION ADMINISTRATION (NIA) FOR THE ESTABLISHMENT OF AN ACCESS ROAD IN PUTATAN, MUNTINLUPA CITY.

WHEREAS, the CITY is a Local Government Unit tasked with providing basic services to its constituents;

WHEREAS, one of these basic services that the CITY is mandated to provide is the construction, rehabilitation and maintenance of roads, streets and access routes;

WHEREAS, the CITY has been experiencing rapid growth and development in recent years as a consequence of which, it has likewise been faced with an increasing number of road users, motorists and human traffic alike;

WHEREAS, such development resulted in the congestion of road users in the CITY's major thoroughfares and even its secondary roads specially during crucial hours resulting in worsening traffic situation;

WHEREAS, the National Irrigation Authority (NIA) is a duly recognized government agency organized pursuant to Presidential Decree No. 552 and is mandated to construct, operate and maintain irrigation facilities within the country;

WHEREAS, the NIA is actually operating and maintaining irrigation facilities within its premises situated in Barangay Putatan, City of Muntinlupa;

WHEREAS, the NIA owns an existing concrete road in the said Barangay measuring approximately 3.5 meters wide and which can be readily connected with other existing roads leading to the National Road and to San Guillermo St., Putatan, Muntinlupa City;

WHEREAS, the CITY is desirous of developing and rehabilitating the said NIA road in order to provide an alternate route and thus, alleviate and decongest the traffic flow in the area and adjacent Barangays;

WHEREAS, the Ayala Property Development Corporation (APDC) has an existing water supply pipeline situated along the subject road stretch and thus, has been duly notified and consulted;

WHEREAS, a development plan of the said NIA road, was agreed upon by the CITY, the NIA and the APDC after due consultation and with the written conformity of the owners of the water supply pipelines along the said road, subject to the following terms and conditions:

1. *The CITY will develop and rehabilitate the subject NIA road, taking into consideration the existing pipeline of Ayala Properties, according to the plan agreed upon at no cost to the NIA whatsoever;*
2. *The CITY undertakes to include the establishment of a drainage ditch of standard design, with proper discharge outlet on both sides of the road;*
3. *The CITY will be responsible for the maintenance and repair of the said road stretch including the putting up of appropriate street signs and markings thereat. The CITY likewise will undertake to provide streetlights on the subject road stretch;*
4. *The CITY will put up fence on both sides of the road for the security of the irrigation pumping plant and other NIA facilities in the compound;*
5. *The CITY will clear the connecting road portion towards the National Road of all encroachments on NIA's right of way to facilitate expedient vehicular movement;*
6. *The CITY shall grant the necessary permit to NIA and to Ayala Properties to undertake repairs on the underground and on its facilities should a need therefor arises. For the said purpose, the NIA/Ayala Properties may close the subject road affected by such repair;*
7. *The NIA undertakes to approve all scope of work, plans and specifications thereof prior to the actual start of the construction subject to the concurrence of the users of the existing water pipelines;*




