WHEREAS, the City Mayor *Hon. Atty. Jaime R. Fresnedi* wrote Secretary *Simeon Datumanong* of the Department of Justice (DOJ) informing the latter of a pending case before RTC Branch 276 docketed as Civil Case No. 00-76 and 00-77 pertaining to the preservation of the status quo regarding the demolition of structures and dwellings at the New Bilibid Prison Reservation, (NBP);

WHEREAS, the *Presidential Commission for the Urban Poor (PCUP)* also wrote the Department of Justice (DOJ) and the Bureau of Corrections to observe the requirements under **Executive Order No. 152** issued by **President Gloria Macapagal Arroyo** regarding prior clearance to be complied with before any demolition can be implemented;

WHEREAS, it appears that there is an on-going demolition conducted by elements of Bureau of Corrections in violation of the pending case in court and in violation of **Executive Order No. 152**;

NOW, THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, by the *Sangguniang Panlungsod of Muntinlupa* that a resolution urging the Presidential Commission for Urban Poor (PCUP) to look into the possible violation of Executive Order No. 152 by elements of the Bureau of Corrections in connection with the on-going demolition in the National Bilibid Prison Reservation, **be passed**.






