WHEREAS, on September 17, 2003, there were three hundred seventy-two (372) homeowners (totally damaged), two hundred eleven (211) renters/sharers and thirty-five (35) boarders that were affected by the fire in Purok 8, Joaquin Compound and Bautista Compound PNR Side Alabang, Muntinlupa City;

WHEREAS, the owners of the houses, renters, sharers and boarders, were rendered homeless by reason of the said conflagration;

WHEREAS, the Social Services Department recommended to declare the affected areas in a state of calamity;

RESOLVE, THEREFORE, AS IT IS HEREBY RESOLVED, by the *Members of the Sangguniang Panlungsod* duly assembled that the area affected by the fire last September 17, 2003 at Purok 8, Joaquin Compound and Bautista Compound, PNR Side Alabang, Muntinlupa City *be declared as in a state of calamity.*
