The Sangguniang Panlungsod shall act on appointment within fifteen (15) days from the date of its submission, otherwise the same shall be deemed confirmed.”*

WHEREAS, ENGR. VICENTE A. NAVARRO meets the required qualifications under the Local Government Code and Qualifications Standard as set by the Civil Service Commission;
