WHEREAS, on August 28,2003, the Department of Health Center for Health development issued guidelines on the evaluation of nominees and the 2003 search for outstanding healthy places;

WHEREAS, the said guidelines provided for ten (10) healthy settings which include: (1) healthy bus station, (2) healthy hospital (secondary), (3) healthy hotel (lodge-in and motel), (4) Healthy Market (public), (5) healthy movie house (class B and C), (6) Healthy Port, (7) Healthy School (Public Elementary), (8) Healthy Workplace (small scale), (9) Healthy Prison and (10) Healthy Rest room (Public);

WHEREAS, the healthy settings provided for therein are not an exclusive list and other health key places can be identified by the local government units in order to adopt the PHPP of the Department of Health (DOH) and in order to develop said places into a healthy one;

WHEREAS, the City Government of Muntinlupa through the Muntinlupa Technical Working Group identified other relevant and existing healthy settings within the City of Muntinlupa in addition to the above-stated places with the exception of Healthy Port such as: Healthy Barangay, Healthy Terminal, Healthy eating place, Healthy Workplace (medium and large scale) and Healthy School (Private Elementary);

WHEREAS, the City of Muntinlupa as one of the cities in metro manila needs to promote the PHPP in order to maintain the cleanliness of the City and support the program of the City Government.;

NOW, THEREFORE, be it resolved as it is hereby resolved, to adopt the Philippine Health Promotion Program (PHPP) of the Department of Health and urging the healthy settings provided therein, which are located within the City of Muntinlupa to actively participate and coordinate with the Muntinlupa Technical Working Group (MTWG), for the proper implementation of the standard evaluation **checklist** setforth by the Program.
