WHEREAS, the owners of the houses, renters, sharers and boarders, were rendered homeless by reason of the said conflagration;

WHEREAS, the Social Services Department recommended to declare the affected areas in a state of calamity;

RESOLVE, THEREFORE, AS IT IS HEREBY RESOLVED, by the Members of the Sangguniang Panlungsod duly assembled that the area affected by the fire last December 23, 2003 at Purok 4, Cupang and #242 Arandia, Tunasan, Muntinlupa City be declared as in a state of calamity.
