WHEREAS, Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that "no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the Sanggunian";

WHEREAS, the City Government of Muntinlupa and the Supreme Court in their pursuit to provide basic services to the people of Muntinlupa, propose to enter into a memorandum of agreement for the lease of the 2nd Floor of De Mesa Building which at present houses the Regional Trial Court Branches 207 and 203;

WHEREAS, the Memorandum of Agreement (MOA) provides among others the following rights and obligations of the parties:

- 1. The City shall shoulder all costs for the renovation and the repair of the space allotted, including the expenses for light, water, telephone and other public utility service used by the courts and officials and personnel housed in the subject building;
- 2. The City shall provide the necessary janitorial and security services for De Mesa Building and shall take charge of the maintenance of the said building, including the grounds thereof and all repairs shall be for its account. However, the Court may augment the maintenance needs of the building whenever necessary;

> 3. The Supreme Court shall pay the rental fees for the whole 2nd floor of the said building, including the space occupied by the Office of the Clerk of Court;

WHEREAS, the pertinent provisions of the "Guidelines on the Occupancy, Use, Operation and Maintenance of the Halls of Justice", issued by the Supreme Court through Resolution dated October 23, 2002 in Administrative Matter No. 01-9-09 SC shall also apply to the building subject of this Memorandum of Agreement;

WHEREAS, there is an available fund from the 2004 Executive Budget.

NOW, THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED by the Sangguniang Panlungsod of Muntinlupa to authorize the City Mayor Atty. Jaime R. Fresnedi to enter into a Memorandum of Agreement with the Supreme Court of the Philippines for the lease occupancy of the 2nd Floor of De Mesa Building located at National Road, Putatan, Muntinlupa City.
