WHEREAS, the owners of the houses, renters, sharers and boarders were rendered homeless by reason of the said conflagration;

WHEREAS, the Social Services Department recommended to declare the affected areas as in a state of calamity;

RESOLVE THEREFORE, AS IT IS HEREBY RESOLVED, by the Members of the Sangguniang Panlungsod duly assembled that the area affected by the fire last August 7, 2004 at Tepaurel Compound, Putatan, Muntinlupa City be declared as in a *State of Calamity*.


