WHEREAS, the term of office of the official representative to the Executive Board of the said League ends with the term of office of an elected Councilor;

WHEREAS, there is a need to re-appoint *Hon. Atty. Raul R. Corro* as official representative of Sangguniang Panlungsod to the PCL and the Metro Manila Councilors' League;

WHEREAS, the Sangguniang Panlungsod of Muntinlupa has passed two previous resolutions in 1998 and 2001 both confirming his appointment to the said League;

WHEREAS, it is the collective opinion of the Council that *Hon. Atty. Raul R. Corro* can ably represent the Council in the League due to his experience and track record as a local official for the last sixteen (16) years, having served in various capacities as *Technical Assistant to the Mayor, Municipal Secretary, City Attorney, Public Information Officer* and now as *City Councilor and Majority Floor Leader* of the *Sangguniang Panlungsod of Muntinlupa;*

WHEREAS, as official representative of the Council to the League during the first term (*July 1, 1998 up to June 30, 2001*), **Councilor Atty. Raul R. Corro** was elected *Director of MMPCL* and was also appointed *Legal Counsel of the Philippine Councilors' League, National Capital Region* and *Chair of the Awards Committee* in the *PCL National Congress* held last *February 19, 1999* at the *Philippine International Convention Center*;

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, that **Hon. Coun. Atty. Raul R. Corro** be re-appointed as *official representative of the Sangguniang Panlungsod to the Philippine Councilors' League and the Metro Manila (Phils.) Councilors' League*.
