WHEREAS, Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that "No contract may be entered into by the Local Chief Executive in behalf of the Local Government Unit without prior authorization by the Sanggunian";

WHEREAS, the City Government of Muntinlupa will enter into a renewal of Contract of Lease over a parcel of land owned by the De Mesa Family to be used as warehouse of the Maintenance Division of the Engineering Department;

WHEREAS, the City Government has previously leased the 400 square meters parcel of land owned by De Mesa Family which expired last December 31, 2003;

WHEREAS, the duration of the Contract is three (3) years from January 1, 2004 to December 31, 2006;

WHEREAS, the contract price of the said parcel of land shall remain the same at *Ten Thousand Pesos (P10,000.00)* per month for *three (3) years* and shall be retroactive
