WHEREAS, the maintenance of peace and order, xxx and the promotion of the general welfare are essential for the enjoyment by all the people of the blessings of democracy (*Section 5, Art. II, 1987 Constitution*);

WHEREAS, the State values the dignity of every human person and guarantees full respect for human rights (*Section 11, Art. II, 1987 Constitution*);

WHEREAS, urban xxx poor dwellers shall not be evicted nor their dwelling demolished, except in accordance with law and in a just and humane manner. No resettlement of urban xxx dwellers shall be undertaken without adequate consultation with them and the communities where they are to be relocated (*Section 10, Art XIII, 1987 Constitution*);

WHEREAS, the State recognizes the Filipino family as the foundation of the nation. Accordingly, it shall strengthen its solidarity and actively promote its total development (*Section 1, Art. XV, 1987 Constitution*);

WHEREAS, any act/s of demolition, especially if it is executed with the use of inmates whose legality is open to doubt, defeats the purpose/s of the aforesaid Constitutional mandate/s;

RESOLVE THEREFORE, AS IT IS HEREBY RESOLVED, requesting *NBP Director Vicente Vinarao, KAMPINA* and *KASAMA AKO Pederasyon* to form a panel of negotiators so that both parties may settle and exhaust all available remedies and peaceful means to address the issue of squatting inside the NBP.

RESOLVED FURTHER, that to ensure neutrality of the talks, this Sanggunian, thru its *Committee on Justice and Human Rights* voluntarily offers itself to be the mediator, if both parties agree.

RESOLVED FINALLY, that the copies of this Resolution be forwarded to *NBP Director Vicente Vinarao, KAMPINA, KASAMA AKO Pederasyon, DOJ, PCUP, NHA, HUDCC*, the *House of Representatives* and *Senate Committees on Housing and Urban Development* for their information and appropriate action.


