WHEREAS, on November 8, 2004, and without giving **SPO4 Efren A. Villanueva** the chance to explain his side on why he should be removed from *Muntinlupa City Police Station, Special Order No. 2379*, by Direction of **Police Director Avelino Razon, Jr.**, signed by **Eric Q. Javier, CSEE, Police Senior Superintendent, Chief Regional Directorial Staff** was received by the *Office of the Chief of Police, Muntinlupa City* to the effect that he be reassigned to *Regional Headquarters Support Group (RHSG), National Capital Region Police Office (NCRPO)*;

WHEREAS, We, in the *City Council of Muntinlupa*, viewed the act of transfer of **SPO4 Efren A. Villanueva** from *Muntinlupa City Police Station* to *Regional Headquarters Support Group (RHSG)* as an act of harassment and tend to undermine the good and effective leadership of **Honorable Mayor Atty. Jaime R. Fresnedi** of *Muntinlupa City* on the maintenance of peace and order in the said City;

WHEREAS, We, in the *City Council* vehemently condemn the act of police authorities for the transfer of **SPO4 Efren A. Villanueva** to *Regional Headquarters Support Group (RHSG)* without due process;

WHEREAS, the transfer of **SPO4 Efren A. Villanueva** disregards the financial and logistical support that the *City Government of Muntinlupa* has been giving to the *Muntinlupa Police Station*;

WHEREAS, the said transfer will have a demoralizing effect among the rank and file policemen of the PNP as good performance and clean record including awards, citations and recognitions are being disregarded due to political harassment;

RESOLVED THEREFORE, AS IT IS HEREBY RESOLVED, by the *City Council of Muntinlupa* condemning the transfer of **SPO4 Efren A. Villanueva** from *Muntinlupa Police Station* to *Regional Headquarters Support Group (RHSG)* without due process and the same tend to undermine the good and effective leadership of **Honorable Mayor Atty. Jaime R. Fresnedi** on the maintenance of peace and order in the *City of Muntinlupa*.

BE IT FURTHER RESOLVED, to furnish a copy of this Resolution to the *Office of the President, Her Excellency President Gloria Macapagal Arroyo, Office of the Senate President, Office of the Speaker of the House of Representatives and Philippine National Police Chief Edgardo Aglipay*.




