Fresnedi in behalf of the City Government to enter into a Contract of Lease with the De Mesa Family over a parcel of land being occupied by the Maintenance Division of the City Engineering Department for its use located at Estanislao St., Lakeview Homes Subdivision, Putatan, City of Muntinlupa.
