WHEREAS, the City Government has been leasing the Doña Zoila Building located at National Road, Putatan, Muntinlupa City for the use of the City Prosecutors' Office with the CTLG Enterprises;

WHEREAS, the period of the contract of lease is for two (2) years from January 1, 2005 to December 31,2006, subject to such extension on mutual agreement of both parties;

WHEREAS, the Contract of Lease is hereby renewed/extended for another two years from January 1, 2005 to December 31, 2006;

WHEREAS, the monthly rental is Sixty Five Thousand Pesos (P65,000.00) starting January 1, 2005;

WHEREAS, there is budget allocation in the 2005 Executive Budget;

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, by the Sangguniang Panglungsod of Muntinlupa, authorizing the Hon. City Mayor Jaime R. Fresnedi to sign for and in the behalf of the City Government the Contract of Lease with the CLTG Enterprises for the lease of Dona Zoila Building being used/occupied by the City Prosecutors Office.
