WHEREAS, the portion of the vacant lot beside the City Terminal in Alabang, Muntinlupa City is temporarily being occupied by ambulant and sidewalk vendors from the Muntinlupa Public Market, who have transferred to the said lot in order to maximize profitability;

WHEREAS, the *Pepsi-Cola Products Phils. Inc.*, a domestic corporation duly organized and existing under Philippine laws has voluntarily offered to construct/install vendor stalls for the use of these displaced ambulant vendors;

WHEREAS, the City Government of Muntinlupa, desirious in providing short-term livelihood to these displaced ambulant vendors, has agreed to allow their temporary use and occupancy of portion of the lot beside the City Terminal in Alabang, Muntinlupa (City, to be known as the "ALABANG NIGHT MARKET";

WHEREAS, the vendor stalls to be constructed/installed by Pepsi will be utilized in the "ALABANG NIGHT MARKET" and shall be at no cost whatsoever to the City Government;

WHEREAS, each vendor shall pay the amount of *Fifty Pesos (P50.00)* per stall daily and *Ten Pesos (10.00)* each for the electricity, effective upon approval of this Resolution until *January 6, 2005*;

WHEREAS, the vendor must be a legitimate and long-time residents of the City and the stalls cannot be subleased nor be allowed to operate after the lapse of period granted for the Alabang Night Market;
