A RESOLUTION AUTHORIZING CITY MAYOR HON. ATTY. JAIME R. FRESNEDI TO OPEN AND MAINTAIN A SEPARATE TRUST ACCOUNT, TO BE KNOWN AS "ROAD FUND DISBURSEMENT ACCOUNT" FOR THE CITY'S SHARE IN THE ROAD USER'S TAX COLLECTION UNDER REPUBLIC ACT 8794, OTHERWISE KNOWN AS THE "MOTOR VEHICLE USERS' CHARGES (MVUC) ACT".

WHEREAS, *Republic Act No. 8794*, otherwise known as the "*Motor Vehicle Users' Charges (MVUC) Act*", gives provinces and cities a *five percent (5%) share* in the collections of *road user's taxes*, the same to be distributed on the basis of the size of road networks and vehicle population in each province or city;

WHEREAS, a letter from *Mayor Jerry P. Treñas, National President of the League of Cities of the Philippines (LCP)* dated *November 25, 2004* was sent to the office of *City Mayor Atty. Jaime R. Fresnedi* informing that the City is among the fifty (50) cities whose *Annual Work Programs* for the utilization of the *Special Local Roads Funds (SLRF)* had been approved by the *Road Board* for actual funding;

WHEREAS, *Article 1.9g* of the Act's implementing rules and regulations, requires the provinces and cities to open and maintain a separate trust account, to be known as the *Road Fund Disbursement Account*;

WHEREAS, it is through said separate account where the City's 2004 share, as well as all subsequent shares in the road fund, shall be deposited;

WHEREAS, the same letter also enjoins the City to immediately open the said separate account as the Road Board shall release the funds anytime after *November 15, 2004*, through the *Department of the Interior and Local Government (DILG)*;

RESOLVE THEREFORE, AS IT IS HEREBY RESOLVED, by the Sangguniang Panlungsod of Muntinlupa in session assembled authorizing City Mayor **Hon. Atty. Jaime R. Fresnedi** to open and maintain a separate trust account, to be known as "**Road Fund Disbursement Account**" for the City's share in the **Road User's Tax** collection under **Republic Act 8794**, otherwise known as the "**Motor Vehicle Users' Charges (MVUC) Act**".

RESOLVED FURTHER, that as soon as the said separate account is opened, the **Local Currency Account (LCCA) Number** of the City shall then be forwarded to the **DILG-Rural Roads Development Project**;




