WHEREAS, a *Memorandum Order* dated *December 1, 2004* was issued by *Secretary Angelo T. Reyes* of the *Department of the Interior and Local Government (DILG)* ordering all local executives to immediately convene their Sanggunian to *declare a state of calamity* as a precondition to the use of the calamity fund for undertaking disaster activities including relief, reconstruction, rehabilitation and other works and services and to implement measures such as but not limited to the following:

1. Organize disaster preparedness and response teams;
2. Activate evacuation sites; and
3. Clear canals and drainages.

WHEREAS, said *Memorandum Order* also advised local chief executives in Luzon to take precautionary measures and contingency plans due to wide swath of "*Typhoon Yoyong*";

WHEREAS, in response to the said *Memorandum Order*, the *City Government of Muntinlupa*, thru the *Sangguniang Panlungsod* hereby declares the areas to be affected by "*Typhoon Yoyong*" as in a *State of Calamity*;

RESOLVE THEREFORE, AS IT IS HEREBY RESOLVED, by the Members of the Sangguniang Panlungsod duly assembled declaring the areas to be affected by the "*Typhoon Yoyong*" within the City of Muntinlupa as in a *State of Calamity*.




