WHEREAS, on December 2, 2004, *Resolution No. 04-059* "A Resolution declaring the area to be affected by the Typhoon Yoyong within the City of Muntinlupa as in a State of Calamity" was passed by the City Council based on the Memorandum Order dated December 1, 2004 issued by the Department of the Interior and Local Government;

WHEREAS, *Typhoon Yoyong* brought havoc to the *City of Muntinlupa* as it caused floods and other calamities;

WHEREAS, such floods and other calamities required evacuation of more than one thousand (1,000) families particularly in *Barangays Sucat, Buli, Cupang, Alabang, Bayanan, Putatan, Poblacion and Tunasan*;

WHEREAS, due to said floods and other calamities, evacuation centers were set-up by the *City of Muntinlupa* in different barangays particularly in *Sucat Sports Complex, Sucat Elementary School, Buli Elementary School, Cupang Elementary School, Mullet Covered Court, Alabang Elementary School, Bayanan Elementary School, Central Elementary School, Tunasan Elementary School and Community Day Care Center*;

WHEREAS, due to said floods and other calamities, residents of different barangays suffered injuries and contracted ailments, such as fever, cough, colds, asthma, bronchitis and other sickness and ailments;


