RESOLUTION NO. 04-063

A RESOLUTION EXTENDING THE CONTRACT OF REN TRANSPORT CORPORATION FOR THE GARBAGE COLLECTION AND DISPOSAL SERVICES FROM JANUARY 1, 2005 UP TO THE TIME THAT A NEW CONTRACT IS EXECUTED IN FAVOR OF THE WINNING BIDDER DECLARED BY THE BIDS AND AWARDS COMMITTEE (BAC) AT THE CONTRACT PRICE OF SIX MILLION EIGHT HUNDRED THREE THOUSAND FIVE HUNDRED TWENTY NINE PESOS AND SEVEN (P6,803,529.07) PER MONTH AND AUTHORIZING HON. MAYOR ATTY. JAIME R. FRESNEDI TO ENTER INTO SUCH CONTRACT IN BEHALF OF THE CITY GOVERNMENT.

WHEREAS, the contract for the collection of garbage between the City Government and REN Transport Corporation will expire on December 31, 2004;

WHEREAS, the REN Transport Corporation requested the City Government to extend the contract for the collection of garbage, thru a letter to the City Mayor dated December 13, 2004, pursuant to paragraph VIII Sub-paragraph 8.2 of the contract, which states that, "at the option of the OWNER and upon conformity of the contractor, the contract may be renewed";

WHEREAS, in the same letter for extension, REN Transport Corporation asked to increase the contract price because of several increases in the price of oil, spare parts and salary of employees;

WHEREAS, the City Government grants an increase of five percent (5%) in the contract price;

WHEREAS, except for an increase of five percent (5%) in the contract price, the contract is hereby renewed under the same terms and conditions of the expired contract;

WHEREAS, the Bids and Awards Committee (BAC) is enjoined to conduct the public bidding within three (3) months from the approval of this resolution;

WHEREAS, as public bidding for the collection of garbage is yet to be conducted, the continuation of the collection of garbage by the REN Transport Corporation is necessary to maintain the cleanliness of the entire City and to prevent the outbreak of any epidemic that maybe caused by uncollected garbage;

WHEREAS, there is a budget for the collection of garbage in the 2005 Executive Budget in the amount of Ninety Million Pesos (P90,000,000.00);

RESOLVE THEREFORE, AS IT IS HEREBY RESOLVED, by the Sangguniang Panlungsod of Muntinlupa to extend the Contract of Services of the REN Transport Corporation for the garbage collection/disposal from January 1, 2005 up to the time that a new contract is executed in favor of the winning bidder declared by the Bids and Awards Committee (BAC) at the contract price of Six Million Eight Hundred, Three Thousand Five Hundred Twenty Nine Pesos and Seven Centavos (P6,803,529.07) per month and authorizing Hon. City Mayor Atty. Jaime R. Fresnedi to enter into such contract in behalf of the City Government.
