**RESOLVE, THEREFORE, AS IT IS HEREBY RESOLVED,** by the **Members of the Sangguniang Panlungsod** duly assembled that the area affected by the fire last April 12, **2004** at Pacwood Site, PNR, Tunasan, Muntinlupa City **be declared as in a state of calamity**.
