A RESOLUTION EXTENDING THE CONTRACT OF THE REN TRANSPORT CORPORATION FOR THE GARBAGE COLLECTION/DISPOSAL FROM JULY 1, 2004 TO DECEMBER 31, 2004 UNDER THE SAME TERMS AND CONDITIONS AT A CONTRACT PRICE OF SIX MILLION FOUR HUNDRED SEVENTY NINE THOUSAND FIVE HUNDRED FIFTY ONE PESOS AND 50/100 (P6,479.551.50) PER MONTH AND AUTHORIZING CITY MAYOR ATTY. JAIME R. FRESNEDI TO SIGN FOR AND IN BEHALF OF THE CITY GOVERNMENT.

WHEREAS, the contract for the collection of garbage between the City Government and REN Transport Corporation will expire on June 30, 2004;

WHEREAS, the *REN Transport Corporation* requested the City Government to extend the contract for the collection of garbage, thru a letter to the City Mayor dated May 25, 2004 pursuant to paragraph VIII Sub-paragraph 8.2 of the contract, which states that, "at the option of the OWNER and upon conformity of the contractor, the contract may be renewed."

WHEREAS, in the same letter for extension, REN Transport Corporation asked to increase by 20% of the contract price because of increase in the price of oil, spare parts and salary of employees;

WHEREAS, the City Government rejects the request for increase in the contract price because the extension granted to the REN Transport Corporation is only six (6) months from July 1, 2004 to December 31, 2004 and there is no budget allocation for the increase;

WHEREAS, as public bidding of the contractors for the collection of garbage is yet to be conducted, the continuation of the collection of garbage by the REN Transport Corporation is necessary to maintain the cleanliness of the entire city and to prevent epidemic that maybe caused by garbage if not collected;
