A RESOLUTION AMENDING A PROVISION IN RESOLUTION NO. 04-023 "A RESOLUTION AUTHORIZING CITY TREASURER NELIA A. BARLIS TO EXECUTE AND SIGN A COMPROMISE AGREEMENT IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA, AS PRIVATE COMPLAINANT IN WITH CONNECTION CRIMINAL CASE NOS. 39620-22 METROPOLITAN TRIAL COURT, BRANCH LXXX (80), ENTITLED "PEOPLE OF THE PHILIPPINES VERSUS ROSARIE RAMIREZ, ACCUSED".

WHEREAS, Resolution No. 04-023, approved the Compromise Agreement which provided that: "the First Party shall recover from the Second Party the total amount of Eight Hundred Twenty Four Thousand Five Hundred Forty Pesos and 80/100 (P824,540.80) representing the face value of the subject checks in the amount of Four Hundred Seventy Nine Thousand Three Hundred Eighty Four Pesos (479,384.00), together with interest due thereon at the rate of two percent (2%) per month for thirty six (36) months or three (3) years or equivalent to Three Hundred Forty Five Thousand Pesos and 48/100 (P345,156.48), to cover all claims which the former may have against the latter in respect of the subject cases";

WHEREAS, The original version of the said Compromise Agreement as submitted by the parties is as follows: "The First Party shall recover from the Second Party the amount of Four Hundred Seventy Nine Thousand Three Hundred Eighty Four Pesos (P479,384.00) to cover all claims which the former may have against the latter in respect of the subject cases":

WHEREAS, accused Rosarie Ramirez through her husband claims that there is a discrepancy in the figures in the approved provision as a result of misapprehension of facts regarding the amount of their obligation as proposed in the original version which amounted to only Four Hundred Seventy Nine

Barlis clarified in her December 20, 2004 letter that the right amount to be paid under the said Compromise Agreement (C.A) is only Five Hundred Ninety Nine Thousand Two Hundred Thirty Pesos (Php.599,230.00) based on the statement of payment, dated September 17, 1998, representing unpaid fees for the period from January 1995 to August 1998 inclusive of surcharge and interest and not *Eight Hundred Twenty Four Thousand Five Hundred Forty Pesos and 80/100 (P824,540.80)*;

WHEREAS, based on the assertion of the City Treasurer and after a review of the facts and circumstances pending the case and the compromise agreement, it is only proper that the questioned provision be amended to conform to the right amount to be paid;

NOW, THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, by the Sangguniang Panlungsod of Muntinlupa a resolution amending a provision in Resolution No. 04-023 "a resolution authorizing city treasurer Nelia A. Barlis to execute and sign a Compromise Agreement in behalf of the City Government of Muntinlupa, as private complainant in connection with Criminal Case Nos. 39620-22 of the Metropolitan Trial Court, Branch LXXX (80), entitled "People of the Philippines versus Rosarie Ramirez, accused".
