WHEREAS, Mr. Florencio G. Ciriaco, Jr. has been in the government service for forty two (42) years now, twenty six (26) years of which was rendered in the assessment service, two (2) years as City Assessor of Caloocan and the last seventeen (17) years as the local assessor of Muntinlupa;

WHEREAS, aside from being the City Assessor, Mr. Florencio G. Ciriaco, Jr. has likewise served the City of Muntinlupa as City Administrator for eight years in concurrent capacity during the term of former Mayor Atty. Ignacio R. Bunye where he did exceptionally well, exhibiting outmost dedication, honesty and efficiency;

WHEREAS, during his incumbency, he has received numerous awards and citations, among them the PAGASA Award from the Civil Service Commission, Galing Pook Award from the Asian Institute of Management and the Ford Foundation, from the Department of Finance for having topped the Written and Oral Examination taken by City and Municipal Assessors all over the country;

WHEREAS, Mr. Ciriaco, has likewise been instrumental in bringing prestige and honor to the City of Muntinlupa by the selection of the Computerized RPTA System of the City Assessor's Office, by the Department of Finance, as the Model Computerized RPTA System in the whole country which has been replicated in 26 localities in the country; and for making Muntinlupa the first local government unit in the Philippines to be ISO 9000-1994 certified;
