LOLITO ROQUE REGARDING THE DESIGN OF A COMPUTER NETWORKING SYSTEM TO INTERCONNECT AND LINK DATA AND RECORDS OF ALL REVENUE-GENERATING OFFICES/DEPARTMENTS.

WHEREAS, there is a need to establish a system of computer networking to interconnect and link data and records from revenue generating offices/departments and establish one central monitoring and control department/office;

WHEREAS, the City Government will save ninety percent (90%) of time in manpower and in materials such as papers and ink;;

WHEREAS, the City Assessors Office (RPT), Treasury, Miscellaneous system have been completed;;

WHEREAS, the City Government shall pay Mr. Lolito Roque *Five Hundred Thousand Pesos (P500,000.00)* from January 31 to March 31 2005;

WHEREAS, Mr. Roque shall submit a certification from the offices/department where the scope of work has already been completed;

WHEREAS, there shall be one (1) year unlimited warranty till May 2006 without extra charge;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the Sangguniang Panlungsod of Muntinlupa to authorize the *Hon. City Mayor Atty. Jaime R. Fresnedi* to sign for and in behalf of the City Government of Muntinlupa the *Memorandum of Agreement (MOA)* with *Mr. Lolito Roque* regarding the design of a computer networking system to interconnect and link data and records of all revenue-generating offices/departments.
