WHEREAS, the Department of Agriculture launched a "Search for Huwarang Palengke, Mura na Malinis Pa", which aims to identify model markets that assist in stabilizing prices of basic commodities and adhere to the Consumer Protection Law;

WHEREAS, the New Muntinlupa Public Market in Barangay Alabang was adjudged as one of the winners of the said search and was granted the prize of Five Hundred Thousand Pesos (P500,000.00);

WHEREAS, the National Agricultural and Fishery Council, an attached agency of the Department of Agriculture, and the City Government of Muntinlupa intends to execute a Memorandum of Agreement to facilitate the release of the aforesaid grant prize;

WHEREAS, Section 455 (b) of the Local Government Code of 1991 provides that for efficient, effective and economical governance, the purpose of which is the general welfare of the City and its inhabitants pursuant to Section 16 of this Code, the City Mayor shall x x x :

"x x x (1) Exercise general supervision and control over all programs, projects, services and activities of the city government, and in this connection, shall:

"x x x (vi) Represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances x x x".
