WHEREAS, City of Muntinlupa has a Vision 2020 which aims to make Muntinlupa a leading investment and business center in the country;

WHEREAS, the City of Muntinlupa needs an Investment Code to enhance clarity, stability and predictability of its business policies and transactions;

WHEREAS, the City engaged the professional services of Atty. Jaime Lopez and Mr. James Paul Esguerra and two research assistants to submit an Investment Code for the final approval of the Sangguniang Panlungsod;

WHEREAS, the total amount to be paid to Atty. Lopez and Mr. Esguerra is One Hundred Fifty Thousand Pesos (P150,000.00) covering the period from July 2004 to August 2005 and Twenty Eight Thousand Pesos (P28,000.00) for Ms. Karla Vasquez and Mr. Apocalypse Alsaybar;


