WHEREAS, on *May 17 & 21, 2005*, there were one hundred five (105) house owners, forty five (45) house renters and ten (10) house boarder/sharer (whose houses were totally damaged) and twenty two (23) house owners, renters, boarders/sharers (whose houses were partially damaged) who were affected by the fire in *Block 10-A Purok 1 and Purok 4, Bayanan, Muntinlupa City*, respectively;

WHEREAS, the owners of the houses, renters, and sharers were rendered homeless by reason of the said conflagration;

WHEREAS, the Social Services Department recommended to declare the affected areas as in a state of calamity;

RESOLVE THEREFORE, AS IT IS HEREBY RESOLVED, by the Members of the Sangguniang Panlungsod duly assembled that the area affected by the fire last *May 17 & 21, 2005* at *Block 10-A Purok 1 and Purok 4, Bayanan, Muntinlupa City*, respectively, be declared as in a *State of Calamity*.






