A RESOLUTION GRANTING ACCREDITATION TO SOUTH CENTRAL PARKING AREA AS A TERMINAL AND GRANTING PERMIT TO OPERATE A JEEPNEY, AUV AND TRICYCLE TERMINAL AT SOUTH CENTRAL PARKING AREA, FILINVEST CORPORATE CITY ALABANG, MUNTINLUPA CITY TO MUNLASAN.

WHEREAS, the various traffic enforcement agencies of the City have reported a worsening traffic situation in the Alabang, area, particularly in front of the Alabang City Terminal along Alabang-Zapote Road;

WHEREAS, the heavy traffic congestion is apparently brought about by public utility jeepneys (PUJ's) and/or operators without a permanent terminal or holding area queuing up along said thoroughfares to pick up passengers, thereby resulting in huge traffic build-ups;

WHEREAS, the traffic condition in the Alabang area is expected to deteriorate even further in the coming months with the impending rehabilitations of the Alabang Viaduct by the Philippine National Construction Corporation (PNCC) and the proposed construction of a pedestrian overpass traversing the subject area;

WHEREAS, Mr. Peter G. Vicente, president of MUNLASAN, Royal Park Homes, Muntinlupa City is applying for a temporary permit to operate a jeepney, AUV and tricycle terminal at South Central Parking Area, Filinvest Corporate City, Alabang, City of Muntinlupa;

WHEREAS, Mr. Vicente has been issued a "certification" dated 28 April 2005 by Filinvest Alabang, Inc., through Mr. Jonas O. Senia, Filinvest Management and Terminal Operations, awarding to MUNLASAN, temporary use of South Station, (as is where is), located in Alabang, Muntinlupa City;

WHEREAS, the MUNLASAN is an accredited association under Kapasiyahan Panlungsod Bilang 02-060;

WHEREAS, the MUNLASAN will provide the basic amenities for it to become a terminal;

WHEREAS, the City Government, through the Sangguniang Panlungsod, is expressly authorized and empowered to, among others:

- "(5) Approved ordinances which shall ensure the efficient and effective delivery of the basic services and facilities as provided for under Section 17 of this Code, and in addition to said services and facilities, shall:
- (v) Regulate the use of streets, avenues, alleys, sidewalks, bridges, parks and other public places and approve the construction, improvement, repair and maintenance of the same; establish bus and vehicles stops and terminals or regulate the use of the same by privately-owned vehicles which serve the public; regulate garages and the operation of conveyances or hire; designate stands to be occupied by public vehicles when not in use; regulate the putting up of signs, signposts, awnings and awning posts on streets; and provide for the lighting, cleaning and sprinkling of streets and public places;
- Regulate traffic on all streets and bridges; encroachments or obstacles thereon and, when necessary in the interest of public welfare, authorize the removal of encroachments and illegal constructions in public places; xxxx";

WHEREAS, the terminal shall abide by the terms and condition provided in Ordinance No. 02-27 and amended by Ordinance No. 02-77 and shall be open to all PUJ's, AUV's and tricycles with the necessary franchise to operate within the city of Muntinlupa from the LTFRB as well as to bonafide transport groups duly accredited with the Sangguniang Panlungsod;

WHEREAS, the said terminal is limited only to jeepneys. AUVs and tricycles and no buses shall be allowed inside the said terminal;

WHEREAS, of the total area reserve for the terminal, a certain portion shall be reserved as parking area for the South Central Mall as provided under the Building Code;
