A RESOLUTION REQUESTING PHILIPPINE NATIONAL CONSTRUCTION CORPORATION (PNCC) TO CONDUCT PRIOR CONSULTATION WITH THE CITY OF MUNTINLUPA IN THE PLANNED REHABILITATION OF THE SOUTH LUZON EXPRESSWAY (SLEX) COVERING THE TERRITORIAL JURISDICTION OF MUNTINLUPA.

WHEREAS, Section 27 of Republic Act 7160, otherwise known as the Local Government Code of 1991 provides that **"No project or program shall be implemented by government authorities unless consultations mentioned in Section 2 (c) and 26 hereof are complied with, and prior approval of the sanggunian concerned is obtained:xxx"**

WHEREAS, Section 2 (c) of same Code also requires all national agencies and offices to conduct periodic consultations with appropriate local government units, nongovernmental and people's organizations and other concerned sectors of the community before any project or program is implemented in their respective jurisdiction;

WHEREAS, Section 26 of the Code further states that **"It shall be the duty of every national agency or government-owned or controlled corporation authorizing or involved in the planning and implementation of any project or program that may cause pollution, climatic change, depletion of non-renewable resources, xxx, to consult with the local government units, non-governmental organizations, and other sectors concerned and explain the goals and objectives of the project or program, its impact upon the people and the community in terms of environmental or ecological balance, and the measures that will be undertaken to prevent or minimize the adverse effects thereof"**;

WHEREAS, the road underneath Alabang Viaduct is the busiest thoroughfare of the City where most of the motorists, whether public or private traverse everyday and where the planned rehabilitation of the SLEX is to be implemented;

WHEREAS, it is of common knowledge that the planned rehabilitation of the South Luzon Expressway (SLEX) would definitely create heavy traffic along the City's main thoroughfare, thus an adverse effect on the City's economic progress due to idle investment;

WHEREAS, the City Government of Muntinlupa thru this Resolution would like to invoke its right under the above-cited provisions of Code in order to take necessary measures to prevent or minimize the adverse effects of the planned rehabilitation of the SLEX, especially on the PNCC's traffic plan during the period of rehabilitation and the toll fees to be charged or collected by them after the completion of the said project;

BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the Sangguniang Panlungsod of Muntinlupa in session duly assembled to request Philippine National Construction Corporation (PNCC) to conduct prior consultation with the City of Muntinlupa in the planned rehabilitation of the South Luzon Expressway (SLEX) covering the territorial jurisdiction of Muntinlupa.

BE IT FURTHER RESOLVED that a copy of this Resolution be furnished to the President of the Philippine National Construction Corporation (PNCC) for its appropriate action.






