A RESOLUTION AMENDING RULE VI, SECTION 24 OF RESOLUTION NO. 04-01, OTHERWISE KNOWN AS THE "INTERNAL RULES OF PROCEDURE FOR THE FOURTH SANGGUNIANG PANLUNGSOD OF MUNTINLUPA", AND THE INCLUSION OF THE RECITATION OF "COUNCILOR'S CREED" AFTER THE SINGING OF THE "MUNTINLUPA MARCH" AS PART OF THE AGENDA AT EVERY SESSION OF THE SANGGUNIANG.

**WHEREAS**, Resolution No. 04-01, otherwise known as "The Internal Rules of Procedure for the Fourth Sangguniang Panlungsod of Muntinlupa" was adopted by the Fourth Sangguniang Panlungsod on July 1, 2004;

**WHEREAS**, Rule VI, Section 24 of said resolution provides that "The Presiding Officer shall open the session by calling the Sanggunian to order. In every session, a one-minute silent prayer or meditation, or at the discretion of the Presiding Officer, an invocation by the Sanggunian Member shall be offered, followed by the singing of the National Anthem, and the singing of the Muntinlupa March";

**WHEREAS**, a resolution enjoining all the Sangguniang Panlungsod/Pambayan comprising the National Capital Region to display the Councilor's Creed in conspicuous places inside their session halls and recite the same as part of their agenda in every session of the Sanggunian, was adopted on July 23, 2005 during the 2<sup>nd</sup> Island Congress of the Metropolitan Manila (Phils.) Councilors League at Asturias Hotel, Puerto Princesa, Palawan;

**WHEREAS**, the Councilor's Creed in a nutshell embodies the commitment of each and every councilor of the Republic of the Philippines to exemplary public service;

**RESOLVED THEREFORE, AS IT IS HEREBY RESOLVED**, by the Sangguniang Panlungsod of Muntinlupa to amend Rule VI, Section 24 of Resolution No. 04-01, otherwise known as the "Internal Rules of Procedure for the Fourth Sangguniang Panlungsod of Muntinlupa", and the inclusion of the recitation of the "Councilor's Creed" after the singing of the "Muntinlupa March" as part of the agenda at every session of the Sanggunian.

**RESOLVED FURTHER**, that the Councilor's Creed shall be displayed in a conspicuous place inside the session hall of the Sangguniang Panlungsod.






