#### **RESOLUTION NO. 114**

A RESOLUTION REQUESTING THE TEMPORARY SUSPENSION OF THE OPERATION OF E-CASINO FILIPINO LOCATED AT THE GROUND FLOOR FESTIVAL MALL, BETWEEN SAVEMORE AND GOLDILOCKS, OUTSIDE PARKWAY ENTRANCE, ALABANG, MUNTINLUPA CITY PENDING THE PUBLIC HEARING, AND FOR THE BUSINESS PERMIT AND LICENSING OFFICE (BPLO) TO ENFORCE THE CONTENTS OF ORDINANCE NO. 99-040.

WHEREAS, Section 458 (a) (1) (v) of Republic Act 7160, otherwise known as the Local Government Code of 1991 empowers the Sangguniang Panlungsod to enact ordinances intended to prevent, suppress and impose appropriate penalties for xxx, establishment and maintenance of xxx, gambling and other prohibited games of chance, xxx, ways to obtain money or property, xxx, and such other activities inimical to the welfare and morals of the inhabitants of the city;

WHEREAS, Ordinance No. 99-040 which was adopted by the Sangguniang Panlungsod of Muntinlupa on August 18, 1999, regulates the establishment of bingo, on-line bingo, jai-alai (off-fronton, horse racing (off-track) and other legalized gambling activities in the City of Muntinlupa;

WHEREAS, Section 2 of said Ordinance provides that" No business permit shall be granted to operators of bingo and other legalized gambling activities without the prior approval of the City Council in a resolution duly passed and without conducting a Public Hearing for the purpose";

WHEREAS, the E-Casino Filipino located at the Ground Floor Festival Mall, between Savemore and Goldilocks, outside Parkway Entrance, Alabang, Muntinlupa City was issued a Mayor's Permit by the Business Permit and Licensing Office (BPLO) on July 11, 2005 for the operation of slot machine, poker games and table games;

WHEREAS, to preserve peace and order in the City, a need to temporarily suspend the operation of E-Casino Filipino pending the conduct of a public hearing is deemed appropriate;

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the Sangguniang Panlungsod requesting the temporary suspension of the operation of E-Casino Filipino located at the Ground Floor Festival Mall, Between Savemore and Goldilocks, Outside Parkway Entrance, Alabang, Muntinlupa City pending the public hearing, and for the Business Permit and Licensing Office (BPLO) to enforce the contents of Ordinance No. 99-040.
