A RESOLUTION AUTHORIZING THE CITY MAYOR, HON ATTY. JAIME R. FRESNEDI TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) FOR THE USE OF A PORTION OF CITY-OWNED LOT LOCATED AT DON JESU\$ BOULEVARD, ALABANG HILLS, BARANGAY CUPANG, MUNTINLUPA CIT FOR THE ESTABLISHMENT OF A POLICE SUB-STATION.

WHEREAS, PAGCOR is donating the amount of Five Hundred Thousand Pesos (P500,000.00) for the construction of a Police Sub-Station (Community Police Assistance Center) on a city government lot-owned at the right side of Don Jesus Boulevard between R.B. Building and CDI Sakata, Inc.;

WHEREAS, the Association of Don Jesus Boulevard Establishments led by its President Mr. Emmanuel Inawat is requesting the City Government of Muntinlupa to allow the use of the said property with a total area of 50 square meters, more or less for the construction of the said Police Sub-Station;

WHEREAS, the said lot is part of the donated road lots and main thoroughfares made by Alabang Development Corporation in favor of the then Municipality of Muntinlupa under its President Ex-Mayor Ramon Bagatsing and former Mayor Maximino Argana;

WHEREAS, the total area to be occupied by the construction of the said sub-station is about 28 square meters (4 x 7 meters):

WHEREAS, the Philippine National Police (PNP), Muntinlupa Chief of Police Roberto Rongavilla, through P/Supt. Demitrio Pagaduan and P/Supt. Juvinille Solapas expressed their support to the said project and informed the committee that Southern Police District Director Wilfredo Garcia made an assurance to provide police personnel to run the police sub-station;

WHEREAS, a MOA shall be entered into by and among the City Government of Muntinlupa, Association of Don Jesus Boulevard Establishments PNP Muntinlupa an Barangay Cupang, to provide for the terms and conditions as well as the duties and responsibilities of each party in the operation and maintenance of the Police Sub-Station;

WHEREAS, the Office of the City Attorney interposes no objection to the proposed construction of the police sub-station in the property owned by the City Government. However, in the proposed MOA the following restrictions shall be made on the use of the said police sub-station;

- 1. The city police shall be strictly prohibited from using the subject lot for any other purpose or business without the prior consent and approval of the City Government;
- 2. The city police shall not, directly or indirectly, sublease, assign, transfer, convey, mortgage or otherwise encumber the subject lot or any portion thereof, or assign the right to use the same, in favor of third person under any and all circumstances; and
- 3. The building or improvement to be built, constructed, and erected for use of the police shall form an integral part of the premises and shall not be removed therefrom, but shall become the exclusive property of the City Government.

WHEREAS, Philmosa Garments, Inc., in a letter dated August 29, 2005 by Mr. Paul Yuan, EVP and General Manager allowed the Association of Don Jesus Boulevard Establishments to utilize part of its property easement approximately 7 meters long and 1 meter wide in order to proceed with the construction of the Police Sub-Station:

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, by the Sangguniang Panlungsod of Muntinlupa authorizing the Ciy Mayor, Hon. Atty. Jaime R. Fresnedi to enter into a Memorandum of Agreement (MOA) for the use of a portion of city-owned lot located at Don Jesus Boulevard, Alabang Hills Village, Barangay Cupang, Muntinlupa City for the establishment of a police substation.

APPROVED, by the Fourth (4<sup>th</sup>) Sangguniang Panlungsod of Muntinlupa, this 1<sup>st</sup> day of September, 2005, on its 49<sup>th</sup> Regular Session.
