FRESNEDI TO ENTER AND SIGN FOR AND IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA THE MEMORANDUM OF AGREEMENT (MOA) WITH PROFESSOR BERNARD LEO KARGANILLA REGARDING THE NEW ADVANCED MANAGEMENT PROGRAM FOR THE PUBLIC EXECUTIVES OF MUNTINLUPA (A.K.A. AMP3) IN THE TOTAL AMOUNT OF THREE HUNDRED THOUSAND PESOS (P300,000.00).

WHEREAS, Professor Bernard Leo Karganilla once served as *Consultant* in the publication of the *Muntinlupa Coffee Table Book* as well as the *Public Information Office (PIO's) Annual Report for 2004*, per *Resolution No. 05-085*.

WHEREAS, time and again, **Professor Bernard Karganilla** represents that he possesses the qualification and experience to undertake the new program entitled "**New Advance Management Program for the Public Executives of Muntinlupa**";

WHEREAS, the objectives of the said program are the following:

1. To equip the selected public executives of Muntinlupa with learning outcomes of understanding the structure and functions of traditional local government in the light of the city's vision and mission, analyze the reasons for the changing face of local government in the light of "Best Value" and other reforms, and undertake case studies of local service delivery, reflecting upon first-hand experience by the student-practitioners;
2. To ingrain the values to all the participants that are needed in the internationalization of Muntinlupa and the upgrading of the city government's services in the context of global and national developments;

3. Benchmark the project with the high-standard public management programs of universities in the Asia-Pacific region and the rest of the world.

WHEREAS, the City Government of Muntinlupa shall grant the amount of **Three Hundred Thousand Pesos (P300,000.00)** to **Professor Bernard Karganilla**, as the project leader, to be disbursed in three tranches, as follows: 1) **Fifty percent (50%)** of total compensation as down payment before the start of the project, 2) **Twenty-Five percent (25%)** of total compensation upon completion of the series of lectures and presentations, and 3) **Twenty-Five percent (25%)** of total compensation upon submission of the final report;

WHEREAS, the duration of the project shall be for three (3) months from September to November of 2005;

WHEREAS, the project leader is expected to run the New Advance Management Program for public executives of Muntinlupa for 2005; provide the project with competent and notable lecturers; provide the project with relevant information-education materials; fulfill the objectives of the project; and award Certificate of Completion to all the participants who shall have completed satisfactorily at least seventy-five percent (75%) of all the session and submitted the requirements of the project;


WHEREAS, the City Government of Muntinlupa shall provide the venue and the facilities for all sessions of the project, and shall ensure the religious and registered attendance of the selected participants in the projects, including the evaluation of the project upon its completion;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the Sangguniang Panglungsod approving the resolution authorizing the **City Mayor Hon. Atty. Jaime R. Fresnedi** to enter and sign for and in behalf of the City Government of Muntinlupa the **Memorandum of Agreement (MOA)** with **Professor Bernard Leo Karganilla** regarding the **New Advanced Management Program** for the public executives of Muntinlupa (a.k.a. AMP3) in the total amount of **Three Hundred Thousand Pesos (P300,000.00)**.
