WHEREAS, in case of renewal of the contract of lease, the monthly rental shall be increased by ten percent (10%);

WHEREAS, the said contract of lease refers to a certain commercial lot with improvements situated at No. 17 National Road, Putatan, Muntinlupa City;

WHEREAS, the said commercial lot is being occupied by the Muntinlupa Renewal Home (MRH) for rehabilitation of drug dependents;




